All shipments must go Freight Collect via Chromalloy Account Number. Please contact your local Site Purchasing Department for account number corresponding to the shipment method directed below.

Documentation Required:

Shipping to All Chromalloy Sites Must Include

- CORRECT SHIP-TO-NAME, ADDRESS, and TELEPHONE NUMBER
- PO NUMBER
- PACKING LIST
- AIR SHIPMENTS – Must include (AWB)
- SEA FREIGHT – Must include (BOL)
- TRACKING INFORMATION (After Shipment Made)

International Shipments to All Chromalloy Sites Globally Must Include

- COMMERCIAL SHIPPING INVOICE

Seller accepts responsibility for providing a Commercial Invoice when necessary for international shipments. All Commercial Invoices must include the following: (i) detailed description of the goods including part number and engine platform, (ii) net and gross weight, (iii) net and gross value, (iv) HTS classification, (v) country of origin, (vi) importer of record (IOR), (vii) the applicable Incoterms (should match those set forth in the purchase order), (viii) final destination of goods, (ix) ECCN or EU dual use rating and (x) export license number, if applicable. If any issues should arise in shipment, supplier must contact Chromalloy, and, in addition, for shipments to the United States only, UPS Supply Chain Solutions. [UPS Brokerage at jfkdocturnover@ups.com should always be included in the “Notify” section of the AWB and Commercial Invoice.]

- Do not buy insurance coverage through carrier

North America Specific

Supplier located in North America – Shipping to North America

- Shipments 150 pounds and less within to be shipped uninsured (without a declared value): Via Standard FedEx Parcel Ground

- LTL (Less Than Truckload) Freight Shipments over 150lbs or palletized: Via LTL freight. Please advise carrier to submit these 3rd party billings to:

Suppliers located Outside North America – Shipping to North America

- Shipments over 25KG and/or palletized: Via UPS SCS
- Shipments less than 25KG: Via FedEx International Economy Standard AND follow FedEx BSO (Broker Selection Option) process when filling out the IAWB (International Airway Bill)
 - a. Paper IAWB: Must use – FedEx Expanded Service International Airway Bill

Supplier located in Mexico – Shipping to Mexico

- Unless otherwise arranged, all suppliers provide to goods / materials at delivered cost.

EU/UK Specific

Supplier located in UK – Shipping to UK (including Northern Ireland)

Parcel

- Parcel Shipments 25KG or less and non-palletized: Refer to Buyer for Courier services within UK unless you have been provided with a FedEx or TNT Account Number to Process Shipments
- Heavy Freight 26KG+ or Palletized: Refer to Buyer for Heavy Freight shipments within UK unless you have been provided with a UPS SCS Account Number to Process Shipments

Supplier located in ROW (Rest of World) – Shipping to UK

Parcel

- Parcel Shipments 25KG or less and non-palletized: Refer to Buyer for Parcel services from ROW to UK unless you have been provided with a FedEx or TNT Account Number and clearance instructions to Process Shipments

Heavy Freight

- Heavy Freight 26 KG+ or Palletized: Refer to Buyer for Parcel services from ROW to UK unless you have been provided with a UPS SCS Account Number and clearance instructions to Process Shipments

Supplier located in EU – Shipping to EU

- Ship as specified on PO Header
- Refer to Buyer for Courier services within EU Countries

Supplier located in ROW (Rest of World)

- Ship as specified on PO Header

Thailand Specific

Supplier located in Thailand – Shipping to Thailand

- Unless otherwise arranged, all suppliers deliver goods / materials at landed cost

Suppliers located in ROW (Rest of World) – Shipping to Thailand

- Shipments 200KG and less from outside Thailand to Chromalloy Thailand and/or Turbine Services Thailand: Via DHL Express Worldwide
- Shipments over 200KG and / or palletized from outside Thailand to Chromalloy Thailand and/or Turbine Services Thailand: Via Air/Ocean/Truck Freight (One time Quote)
- DG (Dangerous Goods) goods from outside Thailand to Chromalloy Thailand and/or Turbine Services Thailand: Via Fedex International Priority Service
- Special requirement in import document (Invoice & AWB)
 - *Thai customs need to declare the “shipping mark” on both invoice & AWB
 - CTHA _ Shipping Mark: Chromalloy (Thailand) Ltd
 - TST_ Shipping Mark: Turbine Services (Thailand) Ltd
